

Arrow Solar Summer Solar Giveaway Terms & Conditions

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.

By entering a Arrow Solar Summer Solar Giveaway (each, a “**Sweepstakes**”), you will be bound by these Terms & Conditions and you acknowledge that you satisfy all eligibility requirements. “**Arrow Solar**” means Arrow Energy Solutions LLC or any of its affiliates.

Eligibility. Open to individual legal residents of Illinois and are of legal age prior to the date of entry. Employees of Sponsor, Arrow Solar and its affiliates, and their immediate family members are not eligible to participate. Participants must provide proof of address. Participants must provide a utility bill as part of the application. Participants must fully complete the application and fully comply with Arrow Solar requests for more information and answer any questions Arrow Solar may have about their electrical usage and property. Participants must have a location feasible and suitable for solar with feasibility and suitability up to the full discretion of Arrow Solar. Eligible participants must live within two hours driving distance of 11470 Industrial Drive, Galena, Illinois 61036.

Sponsor. The Sponsor is the individual or entity offering the Sweepstakes on the Sweepstakes Landing Page. The Sponsor is Arrow Energy Solutions LLC

Winner Selection Method & Notification. The Sponsor will award a prize to one or more individuals who enter at the Sweepstakes point of entry (“**Sweepstakes Landing Page**”) using the selection method identified below. The Sweepstakes Landing Page will specify the Sponsor, prize(s), approximate retail value, how to enter, and when each Sweepstakes begins and ends (which may be sooner than the end dates and times provided depending on the available supply of prizes). Potential winner(s) will be selected at random from among all eligible entries received. Odds of winning depend on the number of eligible entries received.

A winner will be selected within 4 weeks of Sweepstakes end date. If you are a winner, an e-mail notification will be sent to the email address included on your application and a phone call will be made to the phone number provided on your application. If, despite reasonable efforts, a potential winner does not respond within five (5) calendar days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such prize will be forfeited, and an alternate prize winner may be selected.

Winner must complete and pass a site assessment with Arrow Solar within 7 days of being notified of winning. Determination of site assessment passing or failing is up to the full discretion of Arrow Solar. Winner must comply in all phases necessary for the installation and interconnection of the awarded solar system. Winner will need to agree to and sign various applications, paperwork, and contracts prior to award.

Prize and Approximate Value. Participant must have completed the Arrow Solar Summer Solar Giveaway application and fulfilled all eligibility requirements in order to enter or receive a prize. Limit one entry per person and household per Sweepstakes. Prize(s) will be fulfilled by the Sponsor. Each winner will be responsible for paying any taxes and any other expenses incurred, including any

income taxes, sales or use taxes, value added taxes, goods and services taxes, or harmonized sales taxes. Throughout the term of this Sweepstakes, you will provide Arrow Solar with any forms, documents, or certifications as may be required for Arrow Solar to satisfy any information reporting or withholding tax obligations with respect to any payments related to this Sweepstakes. Prize is a 6kW solar system installed by Arrow Solar with an approximated value of \$15,000.00.

Installation must be provided by Arrow Solar and is subject to the terms and conditions of the agreements required for installation. Winner's home must be in suitable condition for product installation. Roof must be without excessive shading or damage. Winner (in collaboration with Arrow Solar) is responsible for obtaining any permit and/or inspection and consent necessary to complete the installation. The Winner will be asked to provide written assurance of his/her willingness to accept the installation, and to provide a waiver of any liability in connection with the installation as a condition of winning this Sweepstakes, including release of any liability relating to any damages that may occur in connection with the installation. Any costs in excess of approximate retail value of the Prize shall be the sole and exclusive responsibility of the Winner. Winner must arrange for prize installation following the award of the Prize and installation must occur within six months of confirmed notification.

Please note some prize conditions. Additional prize conditions and exclusions may apply:

- Prize will not be installed on the following: asphalt shingle roof, metal roof, concrete pier ground system
- Roof must have a pitch of 30% or less
- Winner must have a reasonable amount of usable area for the Prize
- Winner must have an area for the Prize with less than 5% annual shading loss
- Winner will be responsible for any electric service panel upgrades and additional electric panel installations
- Prize does not include ground mount pier related infrastructure costs
- Prize does not include electrical trenching-related costs

Each prize will be awarded "as is" and without craftsmanship warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). If you win a prize, you may not transfer, assign, or redeem the prize for cash. The Sponsor or Arrow Solar may substitute a prize with a prize of equal or greater value. Arrow Solar reserves the rights to the Solar Renewable Energy Credits (SRECs) generated by the awarded system and it is to Arrow Solar's sole discretion whether or not they choose to sell, forfeit, or do nothing with the SRECs. Method of install and equipment used is at the full discretion of Arrow Solar.

How to Enter. You may enter the Sweepstakes via the entry method described below.

1. On the Sweepstakes Landing Page, confirm you have an eligible address and follow the entry form instructions.
2. When you complete the entry form, an Arrow Solar representative will reach out through email or phone for additional information and clarification if needed. Clarifications will need to be provided prior to the Sweepstakes end date

All entries become the property of Arrow Solar and will not be returned. Duplicate entries will be discarded and may result in disqualification. Only fully completed applications are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor. The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries.
